Estate Planning Tips

Conflicts in Your Estate Planning?

Have you possibly made estate plans that conflict with each other? Here are some things to be aware of that can cause legal confusion and negate your wishes in giving to others.

Updating Your Will

If you have recently updated your will, it's a good idea to review the rest of your estate planning to make sure that it agrees with the new will. Check especially:

- Who you want to give to
- What you want to give them
- Who you have named as Beneficiaries on IRAs, investment accounts, and Life Insurance policies. Make sure this planning matches what you have stated in your Will.

Be Aware: An old Will, has the potential to negate or cause confusion about more recent planning that may state different wishes. If you change your Beneficiaries or other planning, be sure to change you Will to reflect these changes.

Life Changes that may affect Your Will

- -Marriage, Remarriage, birth, and death
- -Purchase of real estate; buying or selling a business; property value; retirement
 - -Moving to another state, or new tax laws

If one or more of the situations above apply to you, then take the time to review your present Will, and, if needed, make plans to make a new one!

Include the Janaka Foundation in your will, trust, or as an IRA beneficiary and help Ananda move into the future.
