### Estate Planning Tips for 2019

#### Complete Your Will in 2019!

The Will is the cornerstone of your plan for the inevitable. Yet seven out of eight people die without a Will. And 80% of those who do have a Will, have one that no longer carries out their intentions. Circumstances changed, but their Will does not reflect those changes.

Whatever reasons you may use to <u>forfeit your right</u> to plan the distribution of what you own (your estate) to your loved ones and favorite charities, the fact remains that it is wasteful!

What keeps us from making a Will?

- **1. Simple Procrastination** We think we have more time than we actually do!
- **2. (I have) Too Little Property** Actually, people with small or modest estates cannot afford to think this way. Smaller inheritances can be wasted away in court costs, probate expenses and attorney fees.
- **3. "It's Too Expensive"** A properly drawn Will, directing the distribution of what you accumulated during your lifetime, may be the best bargain of your lifetime.

- **5. A Reluctance to Face Death.** We refuse to face the reality of death because we do not want it to happen.
