### Planned Giving Tips for 2019

## Naming Beneficiaries - Easy to do, but be careful! IRA, Life Insurance, Non-Retirement Accounts, and more ....

To name Beneficiaries on your Retirement account and Life Insurance policy, you can contact the company that administers them and tell them who you would like to name. (Some companies will allow you to do this Online.)

<u>For your Non-Retirement Accounts</u>, naming a beneficiary is usually referred to as a TOD (Transfer on Death).

<u>Checking and savings accounts</u> with your bank can also have named Beneficiaries, sometimes referred to as TOD (Tranfer on Death).

# <u>But</u>, You Must Keep Track of Your Beneficiaries!! If you decide to name beneficiaries, then you will need to keep track of who you have named, and for which accounts.

# **Life Events & Making Changes to Beneficiaries**After each <u>birth, death, wedding or divorce</u> you will need to review your list of Beneficiaries to see if any

changes are necessary.

### Conflict of Planning - Be Careful!

If you make a Will or Trust and name Beneficiaries for your assets, you will need to make sure that these documents name the same Beneficiaries for the same assets you have already named on your separate accounts or policies.

Not doing this could create big problems!
